AIR TRANSPORT CIRCULAR
AT 11/2020

PRECAUTIONARY MEASURES AGAINST NOVEL CORONAVIRUS
(COVID-19)

21th March 2020

1.0 Introduction

On 30th January 2020, the World Health Organization (WHO) declared China's novel coronavirus (COVID-19) outbreak a public health emergency of international concern (PHEIC).

In response to the outbreak of COVID-19, Government of the Maldives is implementing additional measures at all international airports to further minimise the risk of import and community spread of COVID-19 in the Maldives.

2.0 Purpose

2.1 The purpose of this Circular is to advise the airlines, aircraft operators and the relevant airport authorities on the measures taken by the Government of the Maldives relating to the entry of passengers and crew with a travel history to Mainland China, Iran, the South Korean regions of North Gyeongsang Province and South Gyeongsang Province, Italy, Bangladesh, Spain, Île-de-France and Grand Est Regions of France, Bavaria, North Rhine Westphalia and Baden-Wuerttemberg regions of Germany, Malaysia, United Kingdom and Sri Lanka to minimise the risk of spread of COVID-19 in the Maldives.

3.0 Requirement

3.1 Subject to 3.2, all passengers and crew with travel history to the following countries or regions within the last 14 (fourteen) days will not be allowed to enter or to transit through the Maldives as per below effective dates:

- Mainland China, effective 04th February 2020¹
- Iran, effective 26th February 2020²
- South Korean regions of North Gyeongsang Province and South Gyeongsang Province effective 03rd March 2020³
- Italy, effective 08th March 2020⁴
- Bangladesh, effective from 10th March 2020 to 24th March 2020⁵
- Spain, effective from 15th March 2020⁶
- Île-de-France and Grand Est, of France effective from 15th March 2020⁶
- Bavaria, North Rhine Westphalia and Baden-Wuerttemberg regions of Germany, effective from 15th March 2020⁶
- Malaysia, effective from 17th March 2020 -18:00hrs⁷
- United Kingdom, effective from 19th March 2020⁷
- Sri Lanka, effective from 21st March 2020 - 06:00hrs



- 3.2 The following category of nationals originating from and transiting through the aforementioned countries or regions will be permitted entry.
- Maldivian Nationals
 - Spouses of Maldivian nationals
- 3.3 All passengers and crew arriving to the Maldives shall complete the Health Declaration Card as stated in the Air Transport Circular AT 02/2020 dated 02nd February 2020.
- 3.4 Airlines should take all reasonable measures to ensure that all passengers and crew complete the Health Declaration Card and the Immigration Arrival Card before their flight lands in the Maldives, in order to ensure that the services offered are in no way diminished, delayed, deteriorated in manner or timeliness.
- 3.5 Passengers travelling in to the Maldives by air except for tourists checking-in to resorts will be quarantined for 14 (fourteen) days at a place designated by the Government.
- 4.0 **Applicability**
- 4.1 The requirements in this Circular applies to all international airlines, aircraft operators operating to and from Maldives and relevant airport authorities in the Maldives.
- 5.0 **Effectivity**
- 5.1 This Circular supersedes Air Transport Circular - AT 10/2020 dated 17th March 2020, and will come into effect from 21st March 2020. The Circular will remain inforce until rescinded or superseded.
